## **Institutional Aspects - in Creative Accord - of World Trade Organization (Analysis Study on Legal System of WTO)**

### **ABSTRACT**

The subject-matter of this research is the analysis of the Constitutional - Institutional aspect of the W T O under W T O treaty, namely, the scope and status of the W T O, the personal and organic structure, and the rights and obligations, in accordance with creative Convention (W T O Treaty).

We Concluded that the W T O Treaty:

1. Does not expressly State the «international» legal Personality of the W T O, but it stated the legal Personality, namely, in the domestic Field ;
2. Is the essential legal document of the nominate specialized international organization called W T O, after the Innominate international organization in framework of GATT (1947) for the liberation of international Commerce;
3. Is adual nature: Conventional - Constitutional ;
4. Created the general organs (bodies), specialized councils and the Dispute Settlement Body (DSB);
5. Does not Create, The Comission on Trade and environment, and it does not adopt the associate membership.

also, We Concluded that:

1. The role of Dispute Settlement Body (DSB), is notable.
2. From The International Organizations, the European Communities, is alone original member in WTO.
3. The Soft law aspects, in several articles of the W T O treaty (i.e., withdrawal, exceptions and Concessions, exclusion of specific sanction - expulsion -, more than system of vote, Voluntary settlement of Trade disputes in good faith, observance of special circumstances... etc).
4. The most articles of the creative treaty - in the final analysis - are the rights and obligations of the member states, with the exception of the reservation is forbidden.
